

## **INORMATION BROCHURE (B.Ed) for Session 2025-27**

### **General Information:**

Nikhil Banga Sikshan Mahavidyalaya, Bishnupur, Bankura established in the year 1969. It has a long history of reputation in the field of Teacher Education. It has been affiliated by the UGC u/s 2(f) and 12(B), recognized by the NCTE, accredited by NAAC and affiliated under BSAEU. The college is located at the municipal area of Bishnupur Municipality on a land of **14.552 Acres**. The infrastructure of the college is at 'state of the art' with computers, internet, hostels, Gymnasium, Seminar Hall, Multipurpose Hall, Different Laboratories, enriched Library with more than **21000 books** and regular subscriber of reputed Journals. Owing to introduction of NCTE (Norms and Procedure) Regulations, 2014 from the academic session 2015-17, the intake capacity of the college has been reduced to **50** (one basic unit).

### **Admission Information: 2025-27**

1. **NO REGISTRATION FEE for fill up the online form**
2. Successful submission of application online, for admission to B Ed Course 2025-27, to this college does not automatically ensure her/his eligibility for admission to the course.
3. Online application procedure would start from **11.00 am of 02.09.2025** and will be open up to **6.00 pm of 11.09.2025**.
4. Candidates (both Fresh & Deputed) with at least **50% marks** either in the Bachelor's Degree and/or in the Master's Degree in Science/Social Science/ Humanity/ Commerce, or Bachelor's in Engineering or technology with specialization in Science and Mathematics with **55% marks**, or any other qualification equivalent thereto, be eligible for application. There shall be relaxation of **5% marks** in favor of SC, ST and PWD (Persons with disabilities) categories.  
N.B. : 50% or 45% marks (as the case may be) in Bachelor's degree with Hons. may be determined either on the basis of Hons. marks only or on the basis of Hons. marks and marks of the elective subjects taken together.
5. Age of Fresher candidate as on 30<sup>th</sup> August, 2025, would be less than 38 years (relaxation as per Govt. of West Bengal).
6. All the terms and conditions must be read carefully before going to fill up the online form and only when the same is acceptable, complete the process of filling up.

7. First, register yourself with the help of your e-mail Id and Mobile Number. These two are very important, because frequent message etc. may be communicated through the same.
8. Fill up the form electronically as per cues/directions generated while proceeding step by step.
9. Provisional Merit list will be published on the college website: [www.nbsmahavidyalaya.ac.in](http://www.nbsmahavidyalaya.ac.in) only. Tentative date of publication of Provisional Merit List is **14.09.2025**. After publication of Provisional Merit List, if any candidate noticed any discrepancy as regards her/his own eligibility, she/he has to contact to the college office from **14.09.2025 to 15.09.2025** with supporting documents for its rectification. However, in case of any erroneous entry, on the part of the candidate at the time of registration, the same is outside the capacity of rectification.
10. Final merit list will be published on **17.09.2025** on the college website: [www.nbsmahavidyalaya.ac.in](http://www.nbsmahavidyalaya.ac.in) only. Name appearing in the merit list does not entitle an applicant for admission. It is only subject to availability of seat under specific category.
11. **1<sup>st</sup> counselling** will be held on **20.09.2025** and **1<sup>st</sup> admission** will be held on and from **22.09.25 to 23.09.2025**.
12. Verification of all original documents will be made at the time of counselling. If any short-listed candidate fails to produce her/his all original documents, her/his candidature will be automatically cancelled and the next candidate would be given the opportunity for admission.
13. Deputed candidates must submit filled up duly generated format for certification by their employer and government authority duly signed and *copies of Approval for the Post held* at present and earlier along with the *Resolution of the Managing Committee* of the School concerned (present employer) along with a certificate from the School, countersigned by DI of Schools (SE) concerned that they teach classes IX onwards in the school. Teachers working in the Govt.-aided (by the Govt. of West Bengal) institutions only, will be considered under Deputed category. Their candidature will only be treated valid after the format is duly countersigned by the D.I. of Schools (SE)/ competent authority concerned.

14. **Reservation: 22%, 10%, 7%, 6% & 3%** of total seats will be reserved for **SC, OBC A, OBC B, ST & PWD** candidates respectively. OBC certificate will be produced as per latest notification of Govt of West Bengal.

### Selection Procedure:

- For Deputed candidates, short-list will be made on the basis of approved Teaching Experience and subject-group wise.
- For Fresher candidates of all categories (Gen, SC, OBC – A , OBC – B, ST, PWD), short list will be made on the basis of their academic records as follows :-
  - ❖ 10% of the percentage of obtained marks in Madhyamik/equivalent examination.
  - ❖ 10% of percentage of obtained marks in H.S./equivalent examination.
  - ❖ 15% of percentage of obtained in B.A/B.Sc./B.Com General Degree examination or
  - ❖ 20% of marks obtained in B.A/B.Sc./B.Com (Hons) examination (% of marks obtained in this case must be computed considering the marks of Hons. subject only.)
  - ❖ 20% of percentage of obtained marks in Post graduate Degree level.
  - ❖ Additional 5 score point for candidate possessing valid M Phil degree.
  - ❖ Additional 8 score point for candidate possessing valid Ph. D degree (here M Phil will not be counted).

Aggregate of above, calculated for a candidate would constitute the Total Score Point.

18. **Date and time and serial numbers** for provisional admission would be announced after the publication of merit list.

19. The deputed candidates are required to produce **“No Objection Certificate”** from their employer allowing them to pursue the course of studies on full-time basis and *candidates pursuing any other Course of Studies/ Part-time or Full-time Job/Full-time Research Work and the like will not be allowed to pursue the Course simultaneously.*

20. **Intake capacity: 50 (Fifty) for the session 2025-27**

21. Rules of the BABA SAHEB AMBEDKAR EDUCATION UNIVERSITY (BSAEU), the Govt. of West Bengal & the NCTE will be followed.

22. In case of any dispute, the decision of the Admission Committee of the college is final.

23. Hostel Facility is available for **Female students** only.

### **TERMS & CONDITIN FOR ADMISSION TO B-Ed COURSE 2024-26**

Admission to **B Ed Course** in Nikhil Banga Sikshan Mahavidyalaya, Bishnupur, Bankura will be made through 'Online Admission Procedure' only. The terms and conditions of '**Online Admission**' has been described in the following paragraphs which an intending candidate must go through carefully and if the same is acceptable to him/her, only then he/she may proceed for Registration.

#### **Definition of Terms & phrases :**

- **College:** The Nikhil Banga Sikshan Mahavidyalaya, a NCTE recognized and BSAEU affiliated co-educational Teacher Education Institution (TEI) for Secondary level teachers, offering B Ed degree.
- **University:** BABA SAHEB AMBEDKAR EDUCATION UNIVERSITY( BSAEU) under which the college is at present affiliated.
- **Course:** The college is offering 2-Years B Ed Course, as per NCTE (Norms and Procedure) Regulations, 2014 to both pre-service (fresher) and in-service (approved by Govt. of West Bengal and duly deputed) teachers.
- **Applicant:** A person having eligibility as per NCTE norms applying for admission in to this college for obtaining B Ed degree.
- **Deputed:** Duly eligible (as per NCTE Regulation, 2014) person(s), serving as approved teacher in a Govt./Govt.-aided/Sponsored Secondary School, teaching in class IX – XII, duly deputed by the concerned School Authority and the respective District Inspector of Schools (under which the School is controlled), want to apply for admission to B Ed Course in the session 2025-27.

**Fresher:** Duly eligible (as per NCTE Regulation, 2014) person(s), not serving at the time of application or will not serve during September, 2024 to August, 2026 in any school under any Board as a regular /contractual/part-time/para/guest teacher, wants to apply for admission to B Ed Course in the session 2025-27.

- **Eligibility:** Candidates (both Fresh & Deputed) with at least **50% marks** either in the Bachelor's Degree and/or in the Master's Degree in Science/Social Science/ Humanity/ Commerce, or Bachelor's in Engineering or technology with specialization in Science and Mathematics with **55% marks**, or any other qualification equivalent thereto, be eligible for application. There shall be relaxation of **5% marks** in favour of SC, ST and PWD (Persons with disabilities) categories.

**N.B. :** 50% or 45% marks (as the case may be) in Bachelor's degree with Hons. may be determined either on the basis of Hons. marks only or on the basis of Hons. marks and marks of the elective subjects taken together.

- **Reservation:** The reservation of seats for Scheduled Caste (SC), Scheduled Tribe (ST) and Person with Disability (PWD) are as per the rules of the Govt. of West Bengal. A relaxation of 5% marks in aggregate is allowed for SC/ST/PWD.
- The admission charges including admission fee, divided under various heads available in our website.
- The prescribed admission charges have to be paid as per schedule of the college without fail, otherwise, his/her claim for admission is liable to be cancelled.
- The norms set by the NCTE, the Govt. of West Bengal and BSAEU as regards admission to B Ed Course for the session 2024-26 will be followed.
- Read the Admission Information Brochure carefully and follow the instruction for filling up the '**Online Admission Form**' including its successful submission.
- No one can register his/her name more than once as an applicant.
