The above Institutions have many areas of common interest in the field of Teacher Education and hence formed a "Organization" known as "Federation of Teacher Education Institution (Western Cluster).

## 1. Objectives:

- Organization of Games &Sports Championships every year,
- > Organization of cultural programme every year,
- Conducting seminars, symposiums and other types of academic discussions,
- The exchange of faculty to the mutual benefit of the Institutions,
- The exchange of academic materials e.g. library books and journals, laboratory equipments, psychological tests and other relevant items,
- Collaboration in teaching, research and development and consultancy studies in the field of Teacher Education

The colleges under this MoU agree to provide their academic and technical assistance to carry out activities which will foster institutional growth through collaboration and exchange of resources.

### 2. General Terms of MoU

- a. Duration of MoU: This MoU will be effective from the date of the agreement and will have an initial duration of four years. There is also a provision to extend the MoU in case all the parties agree to the same.
- b. Co-ordination: In order to carry out and fulfill the aims of this agreement, each college will empower an appropriate faculty to co-ordinate the implementation of activities. The concerned faculties will meet regularly to discuss the plan, implementation and progress of the activity.
- c. Technical and Financial Support: Technical & Financial support for each activity will be shared by the respective college.
- d. Confidentiality: At any time, after executing the activities of this MOU each college agrees that none of the college will disclose any information in related to these activities without the consent of any of the college which are under this MoU.

4. PSLOWINA.

- e. Termination of MoU: The partnership covered by this MoU will be terminated upon the completion of the agreed for a period of four years. The agreement may also be terminated with a written one month notice from both the sides.
- f. Extension of Agreement: The MoU may be extended according to the willingness of the colleges with prior intimation and permission of the authorities one month before the end of the existing MoU.
- g. Communication: All notices, documents and any other communication under this agreement in connection herewith will be in written form and sent to the postal address, email or fax of the concerned college. Any notice will be effective from the date on which it is signed.
- h. Addendum: Any addendum to this MoU will be in written form and signed by authorities of agreed colleges.
- i. Venue of the Programme: Each college will organize any programme on their own premises in collaboration with other colleges by using their own assistance and resource. Third place may be treated as a venue of any programme by the consultation of the agreed colleges with the financial sharing.

## Other Provisions:

- A. Initially this type of exchange may be implemented in the field of sports activities and cultural programme.
- B. Students, teachers, resource persons and participants may use the resources of colleges under MoU during the exchange and extension activities also.
- C. Teaching may be shared with the students due to prior permission of the authorities with a proper Identity Card.
- D. Students and Teachers may visit and use the college library as well.
- E. All the parties assume that that this agreement does not go against the rules and regulations of the Government of West Bengal and University Grants Commission.
- F. Faculty exchange for special lecture, seminar class and other programme will be made with the consultation of specific faculty as and when needed after the discussion.

#### Declaration:

The provisions mentioned in the above MoU is thoroughly discussed and reached at the consensus that all the institutions will follow the provisions and implement the same.
