

Resolutions Adopted

A general meeting of the Internal Quality Assurance Cell (IQAC), Nikhil Banga Sikshan Mahavidyalaya, Bishnupur, Bankura held on 15.09.2022 at 11.30 A.M. under the Chairmanship of Prof. (Dr.) Bhim Chandra Mondal, Principal, to discuss the agenda as communicated vide letter no. No. F/27/NBSM/2022/1dated 06.09.2022. With prior permission to President, the meeting was started and following resolution has been adopted: Resolution against Agenda 1: The proceedings of the meeting dated 20.07.22 has been read and confirmed by the members.

Resolution against Agenda 2: The Coordinator, IQAC placed the review report by NAAC against the AQAR submitted on 08.03.2022 for the 2017-18 and same has been accepted on 23.3.22. The report suggested to (i) introduce few certificate /Diploma course, (ii) encourage Teachers to use ICT tools for Teaching, (iii) motivate teachers to manage research fund from various agencies, (iv) conduct workshop/seminar on Intellectual Property Right (IPR), (v) Create incubation center, (vi) Motivate teachers to participate in professional development programme and (vii) enhance gender sensitization activities. With regard to above suggestions, the Principal has taken various steps as follows (i) The Principal already communicated with Netaji Subhas Open University (NSOU) requesting to open study centre on Diploma in Yoga Education in our Institution, (ii) All classrooms are connected with Internet and LED projectors where Teachers are using ICT technology to deliver their lecture, (iii) The Principal constantly motivating faculty members for searching for funds for Page 1 of 7

conducting research works and (iv) constantly encouraging faculty members to participate as a result of which 4 and 7 faculty members participated in faculty development programme in the year 2019-20 and 2020-21 respectively. The members discussed the matter and it was resolved that –

- The suggestions made by NAAC be followed. Further resoled to conduct seminar on " Intellectual Property Roght", "gender sensitized programme" and Incubation centre be created for the development of sports skill among under 15 students.

Resolution against Agenda 3: The Coordinator, IQAC placed the review report by NAAC against the AQAR submitted on 30.03.2022 for the 2018-19 and same has been accepted on 4.4.22. The report suggested to (i) conduct the courses through internships and field projects, (ii) motivate teachers to manage research fund from various agencies, (iii) enhance collaborative activities , (iv) sign MoU with Institution of National and International importance, (v) Motivate teachers to develop e-content. With regard to above suggestions, The Principal mentioned that (i) both B.Ed and B.P.Ed run through 4 months and one month internship programme, and (ii) The Principal constantly motivating faculty members for searching for funds for conducting research works. The members discussed the matter and it was resolved that –

- The suggestions made by NAAC be followed. Further resoled to sign MoU with different Institution.

Resolution against Agenda 4: The coordinator, IQAC proposed to AQAR data for the year 2011-22 at an early date. He also informed that Conveners of different categories are continuously collecting requisite data for the year 2021-22. The members discussed the matter and it was resolved that –

- AQAR for the year 2021-22 be uploaded in the NAAC portal within 30th November, 2022.

Resolution against Agenda 5: The Principal placed the proposal of converting the existing Library to digital library. He also informed the members that some company demonstrated their product towards digitalization in front of group of members and estimated cost for the project is approximately **Rs. 1,50,000/0 (Rupees One Lakhs fifty thousands)** only. The members, present in the demonstration process decided to use KOHA software for digitalization purpose. The members discussed the matter and it was resolved that –


